MEETING CALLED TO ORDER BY PRES RAY AT 5:30PM

OLD BUSINESS

COMMISSIONERS HAD A CHANCE TO GIVE THEIR INPUT INTO BRIAN'S 6-MONTH REVIEW. PRESIDENT RAY DEBRIEFED BRIAN ON THE REVIEW PREVIOUSLY AND ALL FELT THE DEPARTMENT WAS GOING IN THE CORRECT DIRECTION. THE SUCCESSFUL COMPLETION OF THE 6 MONTH REVIEW GIVES BRIAN THE INCREASE AS AGREED AS PART OF THE HIRING PROCESS. MORE UPDATES TO THE 2022 BUDGET WILL BE UPCOMING FOR THE NEXT MEETING.
