OLD BUSINESS:

DEPUTY DIRECTOR LEONARD WISHES TO PARTICIPATE IN THE "SILENT WATCH" PROGRAM THAT RAISES AWARENESS TO VETERAN SUICIDE THAT OCCURS DURING SUICIDE AWARENESS MONTH. THE BOARD MEMBERS HAD NO ISSUE WITH PROCEEDING. DISCUSSED THE DCVSO PARTICIPTION IN THE FAIR. THIS YEAR WE WOULD LIKE TO HAVE ALL THE MILITARY GROUPS TOGETHER.
