DIRECTOR REPORT

The Director brought up a request by the VVA to pay for promotion items for approval. After discussion, the Veteran Service Commissioners intent is that the VSC will continue to fund items that directly assist veterans such as funeral honor supplies & needs, flags for markers, and specific event requests for veterans, but not for promotional items. Many promotion items can be requested through the service organization. The VSC also noted that they approved of the great outreach the VVA provides. A potential would be to provide an amount open to all service organization similar to the Memorial Day funding, but would need further discussion.

Director Galligher and Thom Mills discussed the current status of funeral honors in Delaware County. Going forward, the Delaware County Veteran Service Office will be the point of contact for the funeral homes for Delaware County veterans and will disperse funerals to the VVA, DCVA, and potentially the VFW honor guard.
