At a recent conference for Veteran Service Commissioners, a motion was presented to support property tax exemptions. During the discussion phase, it became heated with

questions like, How is it going to help? Do all organizations support, Commissioner Support? In the end, the motion passed the body vote.

Training was another topic of discussion, at the conference where multiple opinions were provided. Some points – does the training have any value to it, is more time for the district meeting?
