#### **OLD BUSINESS:**

### **Bus Trip to Urbana**

Discussed the bus trip to Urbana, Ohio. To move forward more definitive details need to be finalized so that we can get a good quote from a bus company. Lacking dates, times, and amount of people....stops any quotes to be provided. That said, A local bus company was contacted by a cold call asking hypotheticals. Initial financials looks like about 1800 dollars for a bus.

The café that we wanted to eat at stated they can handle 30 people at a time. Splitting the time between the museum and the café may allow more flexibility.

The museum suggest a Tuesday, Thursday or a Saturday. This is when most of the volunteers are there working on their tasks. They suggest to call ahead to make sure volunteers are prepared for the group(s).

After a discussion with the board – It appears Nov 7<sup>th</sup> is the date. Split veterans in two groups – Group A to the café Group B to the Museum then switch.

#### **Communication with FC Veteran Services**

Reviewed the response from Franklin County. The board requested a full disclosure of the email chain from the initial request to present to discuss in a multi county commissioner meeting / training in the future.

#### **NEW BUSINESS:**

Board requested if there has been any update from the Prosecutor's office regarding the question: Can Veteran Services rent/ Lease/ own property.

The deputy director stated that he did have an email exchange (on or near Sept 19<sup>th</sup>) with Vince Villio. There was nothing concrete provided but when their communication mentioned that a CVSO needs privacy due to protected medical information, the response he received from Vince Villio is that is a game changer. The deputy director could not expand on what that meant. The board requested the Deputy Director to send them this email exchange.

New position(s):

The interviews went well. In fact the competition was so close that 2<sup>nd</sup> interviews were completed to make sure the best candidate was going to receive an offer. A list was established for each position and an offer is pending based upon the board's direction.

The top candidate for the CVSO position inquired if the pay rate of \$21-\$25 could be increased. Since the top candidate has years of experience the candidate was wondering if the pay could be increased to match the experience.

The board discussed. The candidate on their first interview stated they were ok with the pay range. The board came to a final conclusion that no change in pay scale would be offered at this time.

A secondary discussion was brought up where if a second CVSO position could be entertained due to the amount of time it takes to bring someone up to speed to function solely as a CVSO and the potential that a retirement is pending within the next year.

The board agrees that a second CVSO position will need to be entertained but at the present time...due in part of the amount of room the office has. The second position will have to be placed on the back burner.
