Representatives from the Daughters of the American Revolution and a representative from the City of Delaware Park and Rec office (Oak Grove Cemetery) were present to discuss their idea to have monuments constructed for the 250th Birthday of the United States and to recognize all veterans from Delaware County who are missing/ unaccounted for in a burial location. They desire the monuments to be constructed at Delaware County's three cities – City of Delaware, City of Sunbury, and the City of Powell.

Continuing talks are progressing with the city leaders and other interested parties. The reason for the meeting with the commission is they are looking for support and seed money to initiate the project. The belief is that if the commission support and provides seed money, that will motivate others to get behind the project and to find avenues to financial support the project as well.

The goal is to have meetings developing a plan that must be finalized by November 2025. The construction of the monuments take a year and the final goal is to have the monuments placed by November 2026.

OLD BUSINESS

Motts Museum – After the visit to Motts museum occurred, the decision was to move forward with the following:

June 25th 2025 – A Veteran only bus trip from the Delaware County Fairgrounds with a pickup at 0900 hrs. By a bus and will transport up to 30 people (including chaperones) to Motts Museum and arrive around 1000 hrs. There will be guided tours provided and lunch will be served on site (outside unless inclement weather). After lunch the veterans can stroll the property to see anything of interest. The bus will pick up the Veterans up around 1:45 and return to Delaware Fairgrounds by 2:45 pm.

CBOC – The naming of the CBOC is still up in the air with different names offered. The commission told Kim G. to discuss at the next roundtable and finalize the name to submit to the State/ Federal authority responsible to getting this official named.

Clippers Game – The commission requested to do May 21st at 1205. Get up to 50 tickets with \$15.00 in clippers cash for each veteran and a bus.

Motion- 25-0414-05 to authorize the purchase of 50 entrance tickets, \$15.00 of food vouchers for each veteran, and a bus for transportation; not to exceed \$2,500.00.

Airshow – At the last meeting the board approved the ability for the office to have a tent and advertisement at the event. The contract was received whereas it went to our legal department to review. At this meeting, the review was not sent back yet and just waiting for legal's advice. There are deadlines that legal is aware of and stated it should be sent back soon.

VetFest- Scheduled for Sept 20th at Veteran Park. The YMCA, National Guard, and other organizations have shown interest in the event. More to follow after another organizational meeting is completed.

ArtFest – May 17 and May 18th – Kim G. and Rey will be handling the details to this event. There is a coloring contest designed to reach all ages with the tomb of the Unknown Soldier to be colored by the younger age groups. The older age groups will be asked to draw and color their own design.

The winners selected will have their artistry skills shown off at the Delaware County Fair

Laundry Love update – This group provided the first quarter of 2025 laundry services to 257 guest adding up to 655 loads of laundry. The cost of each load comes to \$10.12 per load. This does not include the donated food and laundry incidentals (Detergent, Softener, Bleach, and Dryer Sheets). The group identified the veteran demographic in this quarterly group where they found 17 household where the veteran was actually there or a veteran was in their household. This added up to 37 loads of laundry provided.

After discussing this with the commission, they would like to brainstorm how the commission can augment Laundry Love's commitment by identifying and providing funding to Laundry Love for the veteran community. A future discussion will be forthcoming with Laundry Love and Delaware County Veteran Service Staff.

Grady Hospital – The items were purchased that Veteran Services is going to provide Grady Hospital with. Brainteaser games IE word search, Crosswords, coloring books within the genre of the military. There will be tissues and other incidentals. Bags were purchased and just waiting for them to arrive. Once they do, they will be delivered for dispersion.

VETSHOOT – Still being work on with ODNR and the gun range. No date has been set but expected to be sometime late summer early fall most likely after the fair.

RAMPS – In a previous meeting there was a discussion where veteran are in need of a ramp to navigate the stairs but they don't qualify for VA assistance or can afford to purchase. Veteran Services found a solid solution but was informed that the ramps may cause a concern for the building department. A discussion ensued with the building department and as it turns out the building department is not the problem. Each entity's zoning department controls the use of these ramps. So in the original case presented, an application was submitted and waiting for a return answer. If it is approved, the commission will be approached to authorize the purchase of the ramp. This will be the case for any future request. The zoning departments of each entity will have to authorize the use of the semi-permanent ramps.

Heroes Ball – April 26th 2025 is the 2nd annual ball. Karen Kish, Kim Lemons, and Kim Gilley and their spouses will be attending the ball. There are two more place settings for other to attend. Stockhands asked for names.

Woman's Military Group requested if the commission would support a night of comedy at a local venue. The commission understood the request but not sure how this would work as requested. They asked the director to look into this with the auditor and expressed the idea of providing a set amount budgeted and let the group use it as appropriate. No answer was given...waiting on the feedback from the director.

RAMPS – In a previous meeting there was a discussion where veteran are in need of a ramp to navigate the stairs but they don't qualify for VA assistance or can afford to purchase. Veteran Services found a solid solution but was informed that the ramps may cause a concern for the building department. After contacting the building department, come to find out it is a zoning issue. The zoning department of the veteran in question was contacted and received feedback that they do not see it as a permanent structure so they are good for it to be place.

This ramp is for the DCVSO driver's more than it is for the veteran. Without it, the drivers would be placed in a precarious position moving the veteran down a set a stairs that are deemed unsafe, too steep, or simply unable to safely use. The ramp will be purchased and given back when the veteran no longer would require the device.

MOTION 25-0428-09 to approve the purchase of a ramp system capable of Withstanding the weight of the veteran and the driver, making the movement of Veteran safe for both parties. The amount authorized is up to \$5,500.00 dollars.
