#### **OLD BUSINESS:**

## **Grady Hospital**

Bill and Kim G attended a meeting with Grady Hospital staff (Volunteer Supervisor and a Clinical coordinator) to discuss how veteran services can enhance what veterans receive while admitted in the hospital.

Currently, volunteers take care of the veteran program. There are only 2 volunteers for Grady Hospital. They visit on Monday and Wednesdays. However, Dublin Hospital has a more robust program. Veteran Services offered to enhance the program by developing bags of goodies that could be given to the veteran such as office brochure, word search book, puzzle, or light reading material.

The hospital is working internally to see what can be done to identify the veterans more regularly and increase the outreach to veterans at Grady. Over the course of the next couple of weeks, follow up will occur to see how the collaboration is going.

#### **NEW BUSINESS**

"Laundry Love" is a collaborative group of churches and other that provide laundry services to those in need twice a month at Delaware's only coin laundromat. There is a daytime and evening scheduled each month where the group brings in food and will pay for each person's laundry. Each load costs \$11.00.

The leaders met with financial and outreach partners to discuss opportunities to collaborate and potentially provide financial support to the program. It was explained the collaboration with the VSC can only support veterans of Delaware County.

There was a brainstorming session how this could look but prior to any movement data would have to be gathered to confirm if the partnership is worth it. Laundry Love is to collect data on how many veterans use their facilities regularly. Veteran Services is to ask about the need for laundry services and advertise the service. If veterans need the program and there is an uptick in Veterans using the services...the collaboration will take steps forward to support. This will be looped back to the commission in 4 to 6 months to follow up on the data recovered.

### **Snack / Refreshments**

The DAV requested to have table set up that would be stocked by DAV funds for the Veterans to enjoy some coffee and snacks while waiting for their appointment or when stopping by to visit. This request included to purchase a refrigerator to keep items cold and to keep sugary drinks available in case of a diabetic issue that arises.

Discussion – Due to the electrical setup of the building adding items with a high electrical draw will cause issues with the circuitry of the building. A refrigerator was removed from the offices once already. Secondly, there is no room for a snack table in the proposed space. Placing the table in the hallway will allow anyone in the building to partake. Placing the table inside a secured area will encroach on office space. This can be re-evaluated when the office moves to a larger space, but DAV or any organization is invited to place a small table with snacks for veterans in the main hallway.

### **DIRECTOR'S REPORT**

#### **Wreaths across America:**

The discounted offer of buy 2 get 1 free wreath expires soon. Does the commission want to support this program?
