The conclusion of the discussion was to continue our best effort to assist veteran REDACTED by reaching out to organizations like habitat for humanity about home repair, and or receiving another inspection in which details the expenses and severity of the situation.

OLD BUSINESS:

Mash Pantry:

The director and deputy director of the office have been in communication with the MASH pantry. A motion was previously passed by the commission to assist MASH in covering the cost of Ensure drinks for seriously ill, elderly veterans who utilize their services. When the office attempted to pay for the drinks, however, there was some initial pushback from the county, which caused a delay. A timely solution to the problem was found by reaching out to DAV #79, which will provide a gift donation to MASH specifically for the purchase of the Ensure drinks for the veterans. Further discussion to follow to ensure payment was received.

Ramp request:

The board again discussed the request submitted by Suzanne Barr for the installation of a ramp at her home. The proposed ramp would facilitate access for veterans and first responders seeking warmth or the use of restroom facilities. At this time, the request has been tabled until the next meeting, pending the submission of further details.

VVA Trailer:

To assist the VVA in their funeral honors and other events they are requesting a trailer in which they would have the ability to transport different items associated with the events and ceremonies they do. The board continued the discussion of purchasing the trailer for the VVA.

Financial Assistance Policy:

With the pending software upgrade, it is recommended to change the financial policy to drop "Gross" income to "Net" income. Dr. Moore appeared before the board to represent his 501(c)(3) nonprofit, which provides specialized care for veterans facing various mental health challenges. During his presentation, he highlighted critical warning signs and triggers to monitor, particularly during the high-stress holiday season. To illustrate the local impact of his work, Dr. Moore shared demographic data for his current patient base within Delaware County. He currently treats 39 residents across the county, including 11 patients in Lewis Center alone. To sustain these services, he is requesting \$4,750 in funding to support his continued outreach and treatment for struggling veterans throughout the region. The board also took Dr Moore's contact information to assist in reaching other known organizations by the board to possibly assist Dr Moore in the future.

The board received an update regarding the housing situation of veteran REDACTED A quote was presented alongside a proposal to partner with Habitat for Humanity; however, the project is currently pending the completion of veteran REDACTED application. The board concluded that it would continue its efforts to assist veteran REDACTED by identifying organizations willing to fund a professional home inspection. This inspection is a critical next step to determine the total repair costs and ensure the home meets necessary safety standards.

Ramp request:

The board revisited the request submitted by Susan Barr regarding the installation of a ramp at her home for True North. A cost estimate for this project is currently being developed, and further discussion will follow once that information is available. The estimate and logistics will be presented to the board in the future.

Wreaths Across America:

The office received a formal invitation regarding the upcoming Wreaths Across America ceremony. The board confirmed that the office will cover the cost of 100 wreaths for the event. The Director will attempt to process this purchase using their procurement card "P-Card", awaiting successful payment for the wreaths.

Wave Report

The bi-monthly report was distributed to the board via email for review. During the holiday season, the office successfully completed its outreach project, delivering gift bags to veterans residing in nursing homes throughout the county. These bags included treats, a durable mug, holiday cards, and thank-you notes provided by the Olentangy Local School District. Outreach Coordinator Kimberly Gilley organized the distribution to ensure every identified veteran was reached, marking a successful holiday initiative for the office.

End of the year evaluations:

The Director will email the year-end staff performance evaluations to the Commission for their review. During the session, the board discussed potential salary adjustments for office staff, considering the 2025 Cost of Living Adjustment (COLA) based on the federal pay scale.
