OLD BUSINESS

Testimony

Commissioner Santiago Foos presented to the County Commissioners discussing the Veteran Service office and what we provide the veteran community. She highlighted that the office appreciates the "New" building that is in development. During the Testimony, Commissioner Benton identified a significant increase (50%) of requested funds to provide services to veterans.

Trailer cost

Commissioner Hill researched having a mobile trailer costs \$1000-1200 month. An initial \$10,000 for incidental costs will cost around \$48,000.00 for a 2 year contract. County will be responsible for attaching electric. \$700.00 a month for ADA ramps.

Renovations

Wall built - Waiting on a cost / done by the county

Rey's office/ build out making new office space - Cost / done by county

Board asked the director to draft a letter to discuss the modular trailer / and build out request for the office. All 5 commissioners will sign once the letter is approved. It was asked by Commissioner McAllister if we did not have a full-time employee to go into the office created outside Rey Cordero's office if a part-time intermittent employee could use it. Director Galligher stated that until that room is filled a full-time employee could be a multi-use office for all part-time employees, Commissioners, and the Vet Center. Due to the number of people utilizing the office and the small size of the office, it would be STRICTLY kept "sanitized" of personal items.

The idea of having a part-time employee work out of the new CBOC came up, an agreement would need to be made with the VA for this to occur.

House Bill 335 and the choice act

House bill 335 is in the state house potentially dropping property tax to include inside mil-age. This is being watched closely by the State Veteran community with multiple types of opposition.

Choice act is passing the federal side allowing third party agencies to charge up to \$12,500.00 to submit claims on behalf of the veteran.
